Minimum of two of the following achievements: a) The student has demonstrated commercialization of research outcomes conducted during the study period, or b) Received awards or recognition for research achievements, or c) Filed patents or copyrights for research outcomes conducted during the study period, or d) Received awards in invention/innovation/ presentation/exhibition/creative work competitions at the UiTM, national, or international levels
